International Rail Trespass Awareness Day (TRESPAD) 4th edition, 4 June 2025

International Level Crossing Awareness Day (ILCAD) 17th edition, 5 June 2025

Launch conferences in York, G.B.

(*Paris, 2nd June 2025*), The International Level Crossing Awareness Day (<u>ILCAD</u>), a global initiative headed by the International Union of Railways (<u>UIC</u>), is preparing for its 17th annual launch. Its aim is to raise the public's awareness of the risks at level crossings and to increase safety. This campaign, which is widely followed by the world's railway community, is a key event for those involved in the sector.

Around fifty countries generally take part in the annual ILCAD campaign.

Each year, a partner country organises the launch conference, providing an opportunity to share best practice and projects aiming to improve safety and reduce the number of incidents at level crossings.

In the EU and almost everywhere, accidents and fatalities involving level crossings account for almost a third of all rail accidents. If incidents involving pedestrians trespassing on the tracks are included, this figure increases to over 90% of all rail accidents.

All around the world, regardless of country or culture, the rail industry faces the same problems at level crossings and near tracks.

The vast majority of collisions are caused by users deliberately taking risks or making the wrong decisions through oversight, habit, or by being distracted.

Risk assessments, as well technical solutions and innovation are used to improve the most dangerous level crossings.

In addition to safety measures, education/awareness initiatives can be launched to improve safety at level crossings and, if necessary, enforcement measures can then be implemented to counter inappropriate behaviour at level crossings, and on and near tracks.

By raising awareness, educating and working in collaboration with various sectors, <u>ILCAD</u> and <u>TRESPAD</u> strive to reduce the number of incidents and save lives.

This year, we are placing particular emphasis on how "Helping people make good decisions" with the slogan "Safe decisions – every time."

2025 is also the 200th anniversary of the very first passenger railway in the world, so it is fitting that ILCAD campaign will be launched in Great Britain– the original home of the railway. It will be jointly hosted by NETWORK RAIL and RSSB (Rail Safety and Standards Board) at the National Railway Museum in York, the day after TRESPAD, a UIC safety campaign on trespass prevention.

We will be addressing crucial topics such as risk assessment, technical solutions, education, public awareness and cross-sector collaboration (road, rail, police, decision-makers, land-use planning) to ensure rail safety, with speakers hailing from Europe, the USA and industry leaders from the sector, such as IDS (Italy), Schweizer Electronic (Switzerland), Wavetrain (Norway), Kite Projects (G.B.), Gmundener Fertigteile-Bodan (Austria), Capgemini (G.B.), Arentis (G.B.), Hirsch (G.B.), Alstom Group (France), Altpro (Croatia) and Zöllner GmbH (Germany).

These companies are generously supporting the events and will showcase their innovative solutions on-site during the conferences.

A few figures:

- According to UIC estimates, there are more than half a million level crossings in the world, including more than 100,000 in the European Union plus G.B.
- According to the UIC safety report https://safetydb.uic.org in 2023:
 - In 2023, 36 partner railway companies from 33 countries reported an average of 10 victims per week at level crossings, mostly level crossing users (94%).
 - In 2023 the split between accidents with vehicles and accidents with persons at level crossings account for respectively 60% and 40%.
 - Collisions with vehicles resulted in respectively 11% accidents without victims, 17% accidents with 2 and more victims, 37% accidents with one seriously injured person and 35% accidents resulting into a fatality.
 - o For the accidents where an individual was hit by a train at a level crossing, 23% of these accidents resulted into a serious injury, while 77% of these accidents were fatal.
 - Regional and long-distance passenger trains were involved in 78% of level crossing accidents.

➤ The International Union of Railways (UIC)
